


Prevention and suppression operations

The operation of the marine police in human trafficking



- Set up inspection points for all types of fishing vessels at the entrances/exits, ports and fish marketing as well as collecting data on fishing vessels and their crew.
- Patrol the sea with inspection boats, check fishing vessels operating at sea, and collect data on fishing vessels and their crew.
- Investigative teams inspect and collect data on workers at ports and fish marketing.
- Inspect, search, and collect data from karaoke bars and service establishments frequented by fishing crews.
- Coordinate with Songkhla Fisheries Associate to check individuals who will work on fishing vessels before each departure prepare documents, and store them for inspection.
- Assist fishing crews.
- Arrest those who violate human trafficking laws.
- Publicise knowledge about violations of human trafficking laws to vessel owners, captains, and fishing crews.

Pattern of human trafficking routes in the fishing industry

Brokers find victims along the borders of neighboring countries, Hua Lamphong, Sanam Luang, Morchit, public parks, etc. Shelters for victims in Maha Chai, Pak Nam, Samut Prakan, Kanchanaburi, Songkhla, Pattani, etc. Transporting victims by car, van, bus, sneaking along the natural border Brokers at the ports, fish marketing, middlemen that take orders from fishing vessels Accommodation by the karaoke bar or cheap accommodation for waiting to be sent down to the vessel If fishing vessels go fishing outside the territorial Leave it with the tour waters, the victims will not be paid and have no boats or fishing vessels chance to return to shore again.

Groups of victims that can be easily deceived.

Significant performance results from

October 2023 - February 2024

Phuket Marine Police arrest offenders under the Fisheries Act (B.E. 2558)



On 9th December 2023, at approximately 19:00 hrs, Division 8, Thai Marine Police Division conducted an operation to suppress crime, illegal, unreported, and unregulated fishing (IUU), infringing the Fisheries Act B.E.2560 and its amendment B.E.2560, as well as other related laws in the sea area under the responsibility of Marine Police Station 3, Division 8, Thai Marine Police Division. 11 suspects were arrested for:


- 1. Jointly using commercial fishing equipment without permission from the Director General.
- 2. Jointly using a surrounding net to catch anchovies with engine boats in coastal waters without permission.

The evidence seized included:

- 1. A fishing boat named "Chok Amiron" with registration number 635506956, size 8.46 gross tons, without a fishing license or identification mark.
- 2. One surrounding net for catching anchovies measuring 130 meters in length.
- 3. 100 kilograms (fresh) of anchovies.

The arrest location was at latitude 7 degrees 58.13 minutes north and longitude 98 degrees 27.96 minutes east, approximately 0.8 nautical miles from Koh Rang Noi, Ko Kaew Sub-district, Mueang District, Phuket Province. The suspects and evidence were brought to Phuket City Police Station for legal proceedings.

Laem Ngop Marine Police together with Klong Yai Marine Police arrested a Vietnamese fishing vesse



On 17th December 2023, at approximately 08:30 hrs, Division 5, Thai Marine Police Division, in collaboration with Klong Yai Police Station, administrative officers, navy officers, and Thai Maritime Enforcement Command Center, arrested 2 suspects. The evidence included:

1. A green wooden fishing vessel named KG66276TS, powered by a MITSUBISHI engine, without a flag to indicate its nationality. The boat is approximately 3 meters wide, 10 meters long, and 1 meter deep, with an approximate size of 10 gross tons. 2. 4 fishing rods. 3. Approximately 3 tanks of sea snakes.

The suspects were accused of:

- Fishing without a permit or using unauthorized equipment.
- Using a stateless vessel for fishing.
- Engaging in commercial fishing without permission.
- Controlling a vessel entering Thai waters illegally and not passing through immigration checkpoints as required by law.
- Being aliens entering Thailand illegally.

The arrest took place at latitude 11 degrees 38.520 N and longitude 102 degrees 50.724 E (188 bearings at a distance of about 7.6 miles from Enkprasong Pier Klong Yai), which is within the Thai maritime zone and fishing area. The suspects were then brought to Klong Yai Police Station for legal proceedings.

Songkhla Marine Police seize Vietnamese vessel







- The basis of the offense is being an alien residing in the kingdom without permission, which is an offense under Section 81 of the Immigration Act, B.E. 2522.

 They jointly conducted commercial fishing in Thai waters without permission, which is an offense under Section 36 of the Fisheries Act, B.E. 2559. They jointly used a stateless vessel for fishing.
- There are 11 suspects, all of Vietnamese nationality.
- Seized items/damage value: 2 boats and several fishing tools.
- Brief incident: On 22nd February 2024 at 10:00 AM, Division 7, Thai Marine Police Division arrested 11 Vietnamese nationals along with seized 2 vessels and several fishing tools for using a stateless vessel for fishing at latitude 7 degrees 41.9 North and longitude 101 degrees 17.3 East which is about 43 nautical miles east from Songkhla Lake Mouth Area.
- The arresting officer named Pol.Lt.Col.Saranwit Teerawet, inspector of Marine Police Station 1, Division 7, Thai Marine Police Division
