International Dialogue on Migration 2017²

Understanding Migrant Vulnerabilities: A solution-based approach towards a global compact that reduces vulnerabilities and empowers migrants *Geneva, 18-19 July 2017*

The International Organization for Migration (IOM) held the first session of the International Dialogue on Migration (IDM) 2017 on 18 and 19 April at the United Nations in New York on the theme **"Strengthening international cooperation on and governance of migration towards the adoption of a global compact for safe, orderly and regular migration in 2018"**. ³

On 18 and 19 July at the Palais des Nations in Geneva, IOM held its second IDM of the year on the topic **"Understanding migrant vulnerabilities: A solution-based approach towards a global compact that reduces vulnerabilities and empowers migrants"**. The workshop offered Member States and other relevant actors the opportunity to explore all aspects of migrant vulnerabilities from a policy, cooperation and practical perspective. Participants discussed and proposed concrete and implementable measures to reduce migrants' vulnerabilities and respond to their protection and assistance needs.⁴ This second IDM was organized in panels.⁵ The following high level speakers made statements during this IDM at the Palais des Nations in Geneva on the 18th and 19th of July 2017 :

The Delegation of the Order of Malta reaffirmed the Order's commitment to reduce vulnerabilities of migrants, to contribute to protect them, and especially **victims of human trafficking.**

The outcomes of this Geneva workshop together with those of the first workshop organized in New York on 18 and 19 April 2017 will be included in a comprehensive report, which will input into the global compact stocktaking meeting to take place in **Guadalajara (Mexico) from the 4**th **to the 6**th **of December 2017.** It will then feed into the Global Compact on Migration elaboration process as mentioned in the UN General Assembly resolution on the modalities for the intergovernmental negotiations (A/RES/71/280).⁷

The main messages of these two days in Geneva were

• the Global Compact on Migration (GCM) will most probably **not be a binding text** but a soft law instrument like the Paris Agreement on Climate Change, or the 2007 ASEAN Declaration on the Protection and Promotion of the Rights of Migrant Workers, or the 2006 ILO Multilateral Framework on Labor Migration, or the 2008 UN General Comment No. 19 on the right to social security ; the aim of negotiating the GCM is not to agree on a new treaty but to reaffirm existing instruments and mechanisms (Human Rights, International Humanitarian Law, International Labor Law, International Criminal Law) ;

• Governments, and others, including UNHCR, underlined the need to distinguish between refugees and migrants. Nevertheless, **all persons on the move are protected** by Human Rights and Labor Law. Ambassador Laura Thompson, Deputy Director-General of IOM, in her Closing Remarks, clearly stated : 'Existing legal frameworks protect all individuals regardless of "category" and all individuals are rights holders, but effective implementation needs to be better geared to meet the needs of migrants in vulnerable situations. An example of this is the need to implement measures to regulate labour recruiters, including the ratification of Convention 181 on Private Employment Agencies (1997)'.

• **Domestic laws and implementation mechanisms** of the host country, transit country and country of origin are an important source of protection ;

• **Countries of origin** could provide interesting forms of protection through consular and diplomatic services and by concluding bilateral and multilateral agreements ;

• Even if **Governments are the driving force in this negotiation, other stakeholders are involved** and important for the protection of migrants : civil society, including private business, humanitarian and human rights NGOs, the Red Cross and Red Crescent Movement, FBOs, academia, media, diasporas, cities and local communities.
