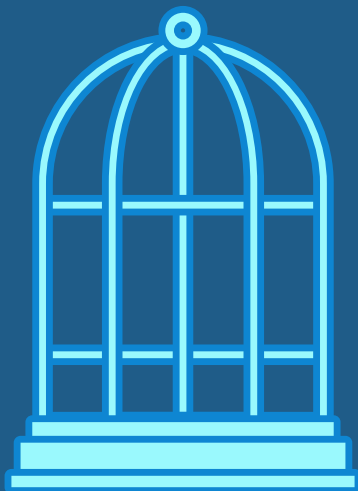

## Agents of Awakening: A Review of Anti- Human Trafficking Activities at U.S. Catholic Colleges and Universities

### Executive Summary

Human trafficking – the use of force, fraud, or coercion to exploit human beings through forced labor, involuntary servitude, or sexual exploitation – is a staggering crime against humanity and requires a multi-pronged response from all sectors of society. Faculty and students at U.S. Catholic colleges and universities are among those organizations engaged and active in the fight against human trafficking, particularly as galvanizing participants in promoting awareness and inspiring engagement and action.

Foundations and Donors Interested in Catholic Activities (FADICA), through an initiative of its International Philanthropy Affinity Group, set out to learn about Catholic colleges and universities that are fostering programs or activities on their campuses. FADICA launched an in-house data collection project to identify and further understand the breadth of such efforts.

Over the course of two summers, a team of FADICA's Philanthropy Leadership Interns gathered information on anti-trafficking activities that raise awareness, provide services, conduct research, and/or educate students and the broader community about human trafficking at over 100 Catholic college and university campuses nationwide. From this aggregated data, FADICA compiled ***Agents of Awakening: A Review of Anti- Human Trafficking Activities at U.S. Catholic Colleges and Universities***, a report that details the research, trends, and exemplary models from these Catholic institutions of higher education.

#### KEY TAKE-AWAYS

- Of approximately 200 schools surveyed, 102 Catholic colleges and universities are engaged in anti-trafficking activities
- Catholic campuses are vital incubators for survivor-based work

## Context

Over 15 years have passed since the United Nations introduced the Protocol to Prevent, Suppress, and Punish Trafficking in Persons (the Palermo Protocol), and nearly the same amount of time has passed since the United States enacted the Trafficking Victims Protection Act of 2000 (TVPA). Yet, according to the International Labor Organization's 2012 estimate, 21 million victims of forced labor remain exploited worldwide.<sup>1</sup> Of the 21 million trafficking victims globally, 4.5 million people are victims of sexual exploitation, and roughly 14.2 million individuals are entrapped in forced labor.<sup>2</sup>

The U.S. State Department's 2016 Trafficking in Persons (TIP) report detailed critical successes, especially in the area of awareness campaigns, including innovative examples from Slovakia to India to Peru.<sup>3</sup> However, progress remains measured and challenges steep in protecting populations most vulnerable to trafficking, including migrants, women, and children.

Human trafficking – the use of force, fraud, or coercion to exploit human beings through forced labor, involuntary servitude, or sexual exploitation – is a staggering crime against humanity. The sale and exploitation of human beings is the most lucrative illicit activity behind only the illegal drug trade.<sup>4</sup> On February 8, 2017, the annual International Day of Prayer and Awareness Against Human Trafficking, Pope Francis called for “[a]ll efforts...to eradicate this shameful and intolerable crime.”<sup>5</sup> Leadership from Pope Francis and others committed to the fight against human trafficking has brightened the spotlight on this violence against humanity and social justice.

The prevalence and complexity of human trafficking requires a response from all sectors of society. Preventing human trafficking and protecting victims and survivors cannot fall solely to legislators, social workers, and law enforcement. Indeed, Pope Francis emphasized that “organizations in civil society, for their part, have the task of awakening consciences and promoting whatever steps are necessary for combating and uprooting the culture of enslavement.”<sup>6</sup> Students and faculty at U.S. Catholic colleges and universities are engaged and active in the fight against trafficking, particularly as agents of awakening and education.

## Motivation and Origins

At FADICA's 2016 Annual Symposium, Dr. Roza Pati of St. Thomas University's Human Trafficking Academy (Miami Gardens, FL) shared her program's mission and success with members of FADICA's Anti-Human Trafficking affinity group. Inspired by the program's impact on the university community, broader community, and individuals engaged in anti-trafficking work, FADICA affinity group members and staff set out to learn about other Catholic colleges and universities fostering similar programs and/or activities on their campuses. FADICA then launched an in-house data collection project to identify and further understand the breadth of anti-human trafficking efforts at U.S. Catholic institutions of higher education.

FADICA's Philanthropy Leadership Interns helped make this project possible. The Philanthropy Leadership Intern Program (PHLIP) at FADICA employs qualified undergraduate and graduate students who contribute to the organization's mission and programs, including research to serve a vital Church and Catholic activities. Student interns also learn about Catholic philanthropy, the Church, and Catholic social teaching. This project benefited significantly from the work of four undergraduate and post-graduate students from Trinity Washington University, St. Joseph's University, University of California Los Angeles, and Northern Kentucky University. Over the course of two summers, the FADICA intern team gathered information on anti-trafficking activities at over 100 Catholic college and university campuses nationwide.

This brief report outlines key observations from the FADICA data collection and summarizes existing anti-trafficking activities on U.S. Catholic campuses. The report aims to “lift up” the diverse campus anti-trafficking efforts and programs to raise awareness and foster exchange of ideas and approaches. American colleges and universities are uniquely suited to develop and expand programs and activities that serve anti-trafficking priorities. Catholic schools in particular, informed by Catholic social teaching and infused with the values of service and justice, are ripe environments for incubating new programs, commissioning research that supports human rights, encouraging campus and community education and engagement, and restoring human dignity and inclusion among peers.<sup>7</sup>

The goal of this report is to aggregate publicly available information about anti-trafficking efforts on college campuses and to laud and highlight their exceptional work. By shining a light on the contributions that Catholic colleges and universities are making in the fight against human trafficking, FADICA hopes to spread the good news of this engagement and solidarity, and encourage its growth.

## Definitions

It is important to note that human trafficking statistics included in this report may underestimate the actual number of victims due to the complexity and many obstacles to data collection. Human trafficking is inherently clandestine, which often makes reaching victims and survivors dangerous for victims, survivors, researchers, and service providers. Additionally, though trafficking in persons does not always involve movement within and across state lines, the transient nature of human trafficking further obscures the scope of the issue. Furthermore, the stigmatization associated with forced labor, and especially sexual exploitation, suppresses victim self-identification which also hinders accurate data.

For the purposes of this research, FADICA used the United Nation’s definition of human trafficking from the Protocol to Prevent, Suppress and Punish Trafficking in Persons (TIP Protocol):

*Trafficking in Persons is “the recruitment, transportation, transfer, harboring or receipt of persons, by means of the threat or use of force or other forms of coercion, of abduction, of fraud, of deception, of the abuse of power or of a position of vulnerability or of the giving or receiving of payments or benefits to achieve the consent of a person having control over another person, for the purpose of exploitation. Exploitation shall include, at a minimum, the exploitation of the prostitution of others or other forms of sexual exploitation, forced labor or services, slavery or practices similar to slavery, servitude or the removal of organs.”<sup>8</sup>*

In the United States and internationally, a three-pronged approach encompassing prevention, protection, and prosecution strategies is used to combat human trafficking. The “3P” paradigm, which now includes a fourth “P” for partnership, is outlined in both the TIP Protocol and the United States’ Trafficking Victims Protection Act (TVPA). Each of these approaches is defined below:<sup>9</sup>

**Prevention** primarily focuses on raising awareness of human trafficking and educating communities about vulnerable populations and victim identification. More recently, amending and enforcing labor laws as well as monitoring supply chains and reducing the demand for commercial sex have been recognized as essential components of prevention.

**Protection** includes victim identification and providing both emergency and long-term services to survivors as they rebuild their lives.

**Prosecution** encompasses law enforcement’s response to human trafficking. This response entails both passing effective anti-trafficking laws and enforcing those laws through vigorous prosecution and appropriate sentencing of traffickers.

*Partnership* has recently been added as the “4<sup>th</sup> P” to highlight the valuable contributions that all segments to society – not just service providers and law enforcement – can make to anti-trafficking efforts.

Many of the campus activities or programs included in this report align with the “4P” paradigm, most specifically through prevention and partnership.

### Information Collection Process

In the summer of 2016, FADICA gathered information about 210 U.S. Catholic colleges and universities’ anti-trafficking efforts. The list of 210 institutions is a subset of the USCCB list of Catholic colleges and universities in the United States, and was refined by excluding Catholic seminaries or divinity schools.<sup>10</sup> Of the 210 Catholic colleges and universities FADICA researched, we were able to identify 102 schools that indicated through their website that they were engaged in anti-trafficking activities. While most information was collected through a search of the college or university’s website, a number of schools were contacted by phone directly to clarify the details of an anti-trafficking program. A complete list of institutions included in this report can be found in the appendix with respective key programs or activities. In addition, Julie L. Burdick, Vice President for Enrollment and Student Success at Ohio Dominican University, shared similar research with FADICA which augmented our data.

Additionally, in July of 2017, FADICA conducted phone interviews with several universities about specific anti-trafficking programs to gain a deeper understanding of the activities and successful elements of those programs. The “Noteworthy Programs” section of this report highlights three of those programs.

### Limitations

FADICA’s report relies primarily on information publicly available on each institution’s website; therefore, this report is neither comprehensive nor exhaustive. We acknowledge that anti-trafficking events or programs not publicized on an institution’s website were likely excluded from this report. For this reason, it is very likely that there are additional Catholic colleges and universities engaged in anti-trafficking efforts, and additional programs at listed universities that are not included in this report. The information reported in the summary data spreadsheet (see appendix) is intended to serve as a “living, breathing” document that will grow and be amended as existing programs and activities are surfaced and new efforts are developed. FADICA welcomes inputs and details from Catholic colleges and universities across the U.S. to improve this aggregate resource.

Due to time and resources, FADICA’s study is also limited to Catholic colleges and universities in the United States.

### Key Observations

Out of the 210 Catholic colleges and universities that FADICA researched, 102 (48.5%) schools included information on their websites indicating that they were engaged in anti-trafficking activities. These activities ranged from informal conversations led by student clubs to established research programs on human trafficking.

The majority of these 102 institutions support prevention efforts through education and awareness-raising. Many institutions have held anti-trafficking seminars and conferences that educate students about existing protection and prosecution efforts. Some universities are directly participating in protection and prosecution through programs that provide services to victims of trafficking or offer trainings to law enforcement officials. Examples of such programs are provided in the “Noteworthy Programs” section of this report.

For each school, FADICA identified a program(s) on campus that exhibits direct or indirect anti-human trafficking mission and activities. Many schools have student clubs dedicated to anti-trafficking efforts, several schools offer academic courses for credit about human trafficking, and some schools have hosted conferences about modern-day slavery. It is worth noting that at several schools, Campus Ministry is the primary incubator of anti-trafficking programming. On other campuses, various academic departments serve as the main incubator of anti-trafficking activity on campus.

The principal mission of anti-trafficking programs at nearly all of the institutions is to raise awareness on campus or educate students about human trafficking. Some schools and programs explicitly state an intent to move students to action (for example through volunteering or fundraising). Other schools go beyond the campus grounds, and seek to educate and engage the proximate community (as opposed to among students only). All anti-trafficking programs included in this report are designed for students, while some also engage community members and/or policymakers.

The primary programs included in this report focus on the following specific anti-trafficking activities:

- Academic opportunities, which include courses and seminars for credit, internships, and fellowships on human trafficking.
- Fundraising activities, from which proceeds serve survivors and/or activities against human trafficking.
- Formal meetings, lectures, symposia, panel discussions, and gatherings which are formally scheduled to discuss human trafficking.
- Informal conversations, awareness and social-media campaigns, student-led discussions, or breakout sessions during an event.
- Research on human trafficking prevention, protection, prosecution, trafficking survivors, trafficking patterns, or traffickers.
- Student clubs or groups committed to anti-trafficking awareness, discussions, programming, and/or activities.
- Prayer, including participation in international days of prayer and campus or community vigils.

The percentage of participating Catholic colleges and universities engaged in each type of anti-trafficking activity can be seen in Chart A on page 6.

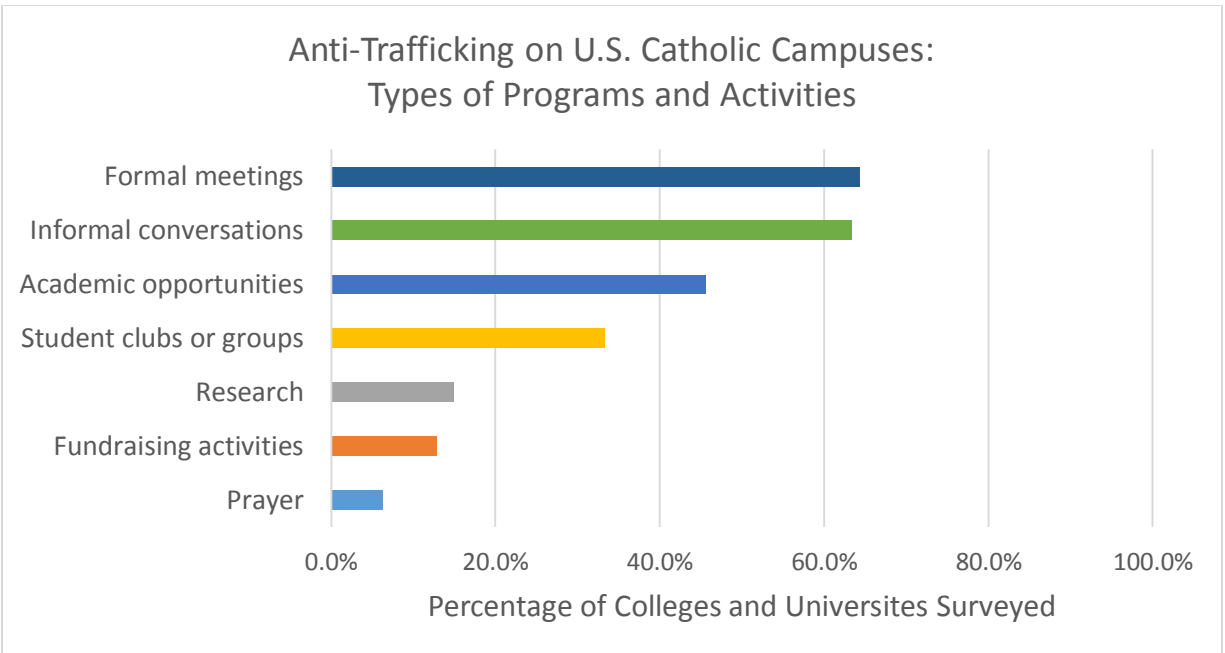

## Conclusion

“There is no better place to establish survivor-based programs,” Rachel Monaco-Wilcox of the LOTUS (Legal Options for Trafficked and Underserved Survivors) Legal Clinic aptly stated. Campuses are innovative, dynamic, and constructive. Additionally, the academic underpinnings of a university can provide strong, well-researched support for anti-trafficking activities, which places universities in a unique position to engage in anti-trafficking work.<sup>11</sup> Shea Rhodes, Director at the Institute to Address Commercial Sexual Exploitation at Villanova School of Law, noted that the academic environment of a campus also creates a platform to engage in serious, cross-disciplinary conversations about difficult topics, such as the pervasiveness of human trafficking.<sup>12</sup> Moreover, Catholic universities are well-suited to serving anti-trafficking efforts given the critical values of social justice and service that are deeply embedded in their founding and mission.

Human trafficking is a global scourge that will not be easily eradicated. However, the impact of the numerous anti-trafficking activities at Catholic institutions and the programs featured in this report inspire hope for progress in the work to end human trafficking.

While many campuses are contributing to the fight against human trafficking, there is still tremendous opportunity. By sharing the current impressive engagement and diverse approaches on Catholic campuses, FADICA intends to affirm the spirit of solidarity evident in these activities, to contribute to the exchange of ideas and lessons learned, and to inspire continued efforts. As centers for innovation in their communities, college campuses have the potential to raise awareness not only among their student population, but in their surrounding communities as well.

This review is by no means a final report on the state of anti-human trafficking efforts on Catholic campuses, but rather a preliminary collection effort of such programs. It is our hope that readers can use the attached spreadsheet and Google map as a potential tool to support any desired communication and exchange between schools on campus anti-trafficking efforts.

# Noteworthy Programs

*There are myriad effective anti-human trafficking programs, projects, institutes, and centers on Catholic campuses nationwide that are included in this review. This section highlights three programs at or affiliated with Catholic institutions of higher education that are creatively engaged in anti-trafficking research, education, outreach, and advocacy.*

## Human Trafficking Academy at St. Thomas University School of Law

**ABOUT:** The Human Trafficking Academy is a part of the LL.M./J.S.D. program in Intercultural Human Rights at St. Thomas University School of Law. The Academy was founded in 2010 through a grant from the United States Department of Justice, Bureau of Justice Assistance. The Human Trafficking Academy is a week-long training program dedicated to outreach, awareness, and in particular, specialized training and technical assistance to law enforcement, lawyers, healthcare providers, teachers, students, researchers, religious institutions and the community-at-large on issues related to human trafficking. The program, accredited by the Bar Association of Florida, is a 36-credit course designed for individuals directly employed or to-be-employed in anti-trafficking work.



**APPROACH:** The Academy takes a multidisciplinary, human rights-based approach to anti-trafficking education with an emphasis on victim-centered training and the dignity of survivors. St. Thomas' Human Trafficking Academy was among the first institutions nationwide to educate and train professionals who develop policy and the officers who enforce the laws. This pioneering work is rooted in Catholic social teaching and seeks to eradicate slavery in all its forms. According to the Academy's director, Dr. Roza Pati, the Human Trafficking Academy's general mission is to educate and empower the community-at-large to acknowledge human trafficking; to raise awareness and advocate for programs that prevent human trafficking; to identify victims and protect them; and to investigate, prosecute, and convict traffickers.

**IMPACT:** A unique aspect of the Human Trafficking Academy's model is that the program is not limited to law students, attorneys, judges, social workers, or police officers. The Human Trafficking Academy invites anyone interested in addressing human trafficking to participate. In this way, the Academy seeks to educate and engage the general public to contribute to systemic change. The Human Trafficking Academy at St. Thomas University School of Law has formally certified over 350 students and has reached over 6,000 people through awareness and education since inception.

## Modern Slavery Research Project at Loyola University New Orleans

**ABOUT:** Loyola University New Orleans' Modern Slavery Research Project (MSRP) is a research center committed to emancipating victims of human trafficking in Southeast Louisiana, across the U.S., and internationally through survivor-centered, data-driven, and community-based research and training. MSRP focuses on research, legislative advocacy, training, campaigning, and event planning for educational awareness.



**APPROACH:** The Modern Slavery Research Project encourages partnership and emphasizes a collaborative approach to research and education. Most recently, and in association with Covenant House International, MSRP produced a report on labor and sex trafficking among homeless youth in ten cities across the United States and

Canada. The report included a multi-pronged plan to improve protections for youth that is both applicable and adaptable for service providers and legislators currently working with vulnerable populations.

In addition to local and national research and training of law enforcement, medical professionals, social workers, and teachers, MSRP takes a special interest in educating and training students to lead the fight against human trafficking. Director and lead researcher Dr. Laura Murphy, who also teaches a freshman seminar on human trafficking, stresses the vital contributions of student interns to the Modern Slavery Research Project. MSRP values research as an opportunity to propel students into anti-trafficking work and engage them in social justice.

**IMPACT:** In 2015, MSRP conducted a New Orleans-based pilot study that preceded the ten-city study referenced above. The study provided quantifiable evidence to support a \$1.5 million grant application to the U.S. Department of Justice. The grant was awarded and helped create the Greater New Orleans Human Trafficking Task Force, a multi-disciplinary collaboration to end human trafficking.

In addition, approximately 20 students have served at MSRP on projects of local and national concern, several of whom have pursued anti-trafficking work following their internship. MSRP reports that former interns have continued their anti-trafficking efforts in law school, as social workers, and as Fulbright scholars. One former intern started an anti-trafficking organization in Peru and another is working on trafficking issues at the McCain Institute. The compounding impact of engaging students in the anti-trafficking movement is undeniable.

# Institute to Address Commercial Sexual Exploitation at Villanova School of Law

**ABOUT:** Villanova School of Law launched the Institute to Address Commercial Sexual Exploitation (the CSE Institute) in the beginning of the 2015 academic year. The Institute was co-founded by director Shea M. Rhodes, Esq. and faculty advisor Prof. Michelle M. Dempsey, and focuses primarily on data collection and reporting, education, training, and legal research and technical assistance for victims of human trafficking.



## The Villanova Law Institute to Address Commercial Sexual Exploitation

**APPROACH:** The CSE Institute's approach to human trafficking education and awareness includes

collaboration with both undergraduate and law school students. The Institute works primarily with externs and offers academic credit to Villanova law students who research current policy issues and assist with legal services provided to survivors. The CSE Institute also extends opportunities to the undergraduate community. The Institute partnered with faculty members in the Communications Department at Villanova University to create a project for undergraduate communications students to research human trafficking and relevant policy issues for a public website for community awareness building. The project educated the participating undergraduate seniors about human trafficking and modern slavery, and established a relationship between the CSE Institute—a program headquartered at the school of law—and the undergraduate school at Villanova.

**IMPACT:** By working with both law students, who have a clear interest in human rights law and policy, and undergraduates, who may be new to the issue of human trafficking, the CSE Institute serves as a great example of the ways in which cross-departmental partnerships can foster the spread of information throughout various academic communities. Awareness-building and education are crucial first steps in the effort to eradicate human trafficking.

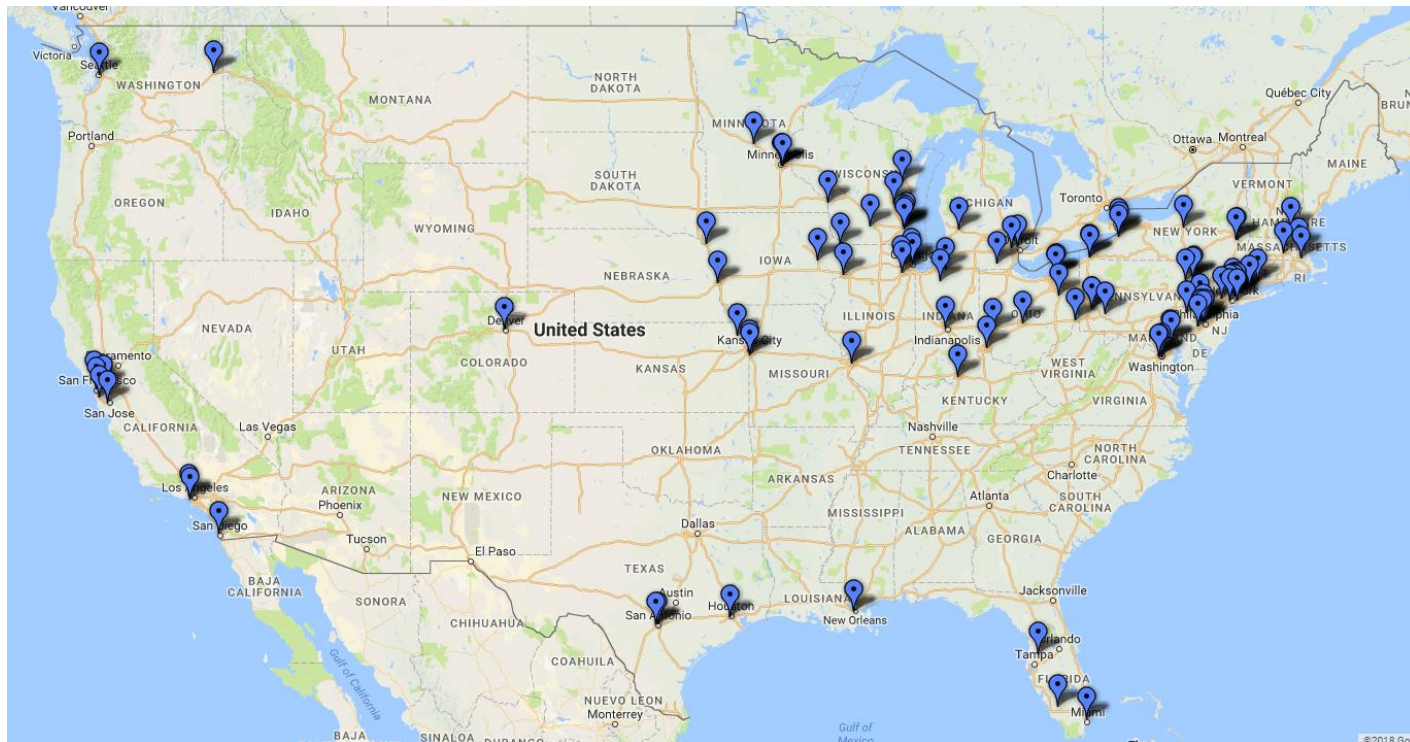
