Global Platform for Disaster Risk Reduction

Biennial global multi-stakeholder forum, recognized by the General Assembly:

- Assess progress on the implementation of the Sendai Framework for Disaster Risk Reduction
- Share practice and knowledge on disaster risk-informed policies, programmes and investments, including on development and climate issues
- Forge partnerships
- Contribute to the deliberations of the High-Level Political Forum (HLPF) on Sustainable Development, General Assembly, and other relevant UN bodies

Multi-stakeholder approach



6th Session of the Global Platform for DRR, 13-17 May, 2019, Geneva

Agenda will include:

- Monitoring and reviewing progress on the implementation of the Sendai Framework, based on countries' reports through Sendai Framework Monitor tool.
- Stocktaking of development and implementation of national strategies and plans for DRR in line with the Sendai target e).
- Focus on themes of the HLPF sessions and specific SDGs to be reviewed in 2019.

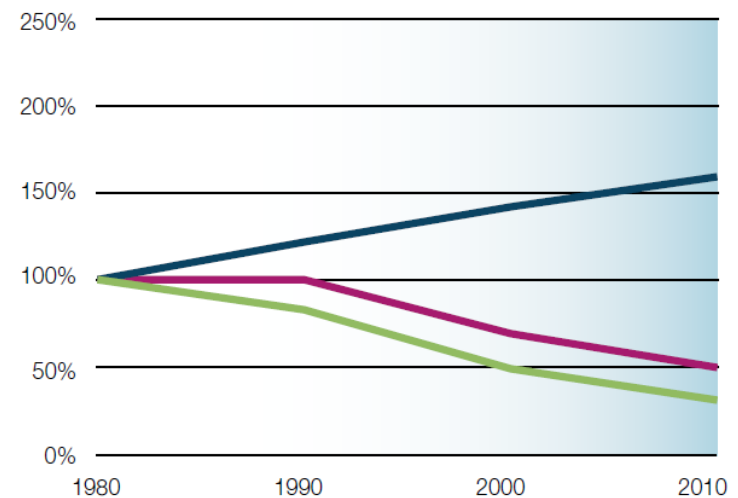

Timeline and key dates:

- UNISDR will open Sendai Framework Monitor on 1st March, 2018
- A snapshot of data on targets a to e, which are relevant for SDG 1,11 and 13 will be submitted to HLPF reporting on 31 March.
- HLPF 2018 will take place in New York, 9-18 July, 2018
- Regional Platforms for DRR will take place in mid-2018 (June-July and November)
- A snapshot of data will be taken from Sendai Monitor as an input for the Global Assessment Report and the Global Platform for DRR, October 2018
- Global Platform for DRR, 13-17 May, 2019, Geneva
- HLPF 2019 will take place in New York, July, 2019
